

# OFFICIAL RULES

## HACKARD LAW FENDER PLAYER SERIES STRATOCASTER HSS GIVEAWAY CONTEST

### NO PURCHASE NECESSARY.

**1. Eligibility:** The Hackard Law Fender Player Series Stratocaster HSS Giveaway Contest (the “Contest”) is open only to legal residents of the United States (excluding its territories and possessions) and Washington D.C. who are at least 18 years of age at time of entry (“Entrant”(s)). Void in Puerto Rico, the Virgin Islands and where prohibited. The Giveaway is sponsored by Hackard Law (“Sponsor”).

**2. Prize:** The Giveaway allows Entrants to enter a random drawing, as described below, on the Hackard Law YouTube Channel (the “Channel”) for a chance at winning a Fender Player Series Stratocaster HSS (“Prize”). The average retail value (“ARV”) of the Prize is \$621.00. The total ARV of all Prizes is \$621.00. **THE ODDS OF WINNING THE PRIZE DEPENDS ON THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED.**

No Prize substitution or cash alternative is allowed except at the sole discretion of Sponsor. If a Prize cannot be awarded due to circumstances beyond the control of Sponsor, a substitute prize of equal or greater retail value may be awarded. The Winner will be solely responsible for all federal, state and/or local taxes, and for any other fees or costs associated with the Prize received.

**3. Giveaway Period:** The Giveaway shall begin at 12:01 a.m. Pacific Time (“PT”) on November 12, 2020 and shall end at 11:59 p.m. PT on December 2, 2020 (“Giveaway Period”).

**4. How to Enter:** To enter the Giveaway you must (a) subscribe to the Channel, (b) “like” the video Law Fender Player Series Stratocaster HSS Giveaway (“Video) and (c) place a comment (“Comment”) on the Video (together the “Entry”). Entries must be received during the Giveaway Period. **ONLY ONE ENTRY IS PERMITTED PER PERSON.**

**5. Winning:** The winner of the Giveaway (“Winner”) shall be chosen by the Sponsor using an app that randomly selects someone from the comments. The Winner shall be chosen by 12:00 PM PST (Pacific Time) on Tuesday, December 4, 2020.

**6. Prize Claim:** The Winner will be notified within two days of the drawing by reply to the winning entry and the posting of a video announcing the Winner. The Winner may be required to execute an Affidavit of Eligibility, a Liability Release, and (where legal) a Publicity Release (collectively, “Prize Claim Documents”) within 3 Days of notification, or as directed by the Sponsor. The failure to respond timely, to the notifications and the failure to provide the Prize Claim Documents will result in forfeiture of the Prize and, in such case, the Sponsor may declare an alternate winner, based on another random drawing. If a Prize goes unclaimed or is forfeited by the Winner, the Prize may not be re-awarded, in Sponsor’ sole discretion.
